<u>Michigan Works Lease Agreement</u>: Meet with Mark Berdan, proposed amended lease and the potential to increase the square footage, to include the Annex.

Proposed lease agreement would increase from \$3.20 per square foot to \$10.00 per square foot. This would increase rent from \$1000.96 per month to \$2300.00 per month. The addition of the Annex to their lease would increase the total rent to approximately \$3128.00 per month. Mary is waiting for a call back from Mark and Michigan Works front office.
